#### METHOD AND PURPOSE OF DATA PROCESSING

Your personal data will be processed with the support of the following means: Mixed - electronic and paper (including portable devices), and with the following purposes: A. Conclusion and execution of a contractual relationship with the customer in all its aspects, including any litigation phase; B. Fulfillment of related legal, tax, or accounting obligations; C. Customer Management (contracts, orders, shipments, invoices); D. Accounting or treasury management. E. Drafting and sending of cost estimates F. Marketing activities.

### **LEGAL BASIS**

Execution of existing contractual relationship with the customer or pre-contractual service(s) requested by the customer. Fulfillment of a legal obligation of the Data Controller. Legitimate interest of the owner in the protection of their rights even in litigation. Assessment, exercise, or defense of a right in court.

## CONSEQUENCES OF FAILURE TO COMMUNICATE PERSONAL DATA

The provision of personal data necessary for the conclusion and execution of the contract and for the fulfillment of any related obligations is mandatory, therefore the refusal to provide them in whole or in part may prevent to conclude and / or execute a contract or to provide the requested services.

### **CATEGORIES OF RECIPIENTS**

## PERIOD OF CONSERVATION

The collected personal data will be kept for as long as necessary to carry out any activities related to the execution and/or conclusion of existing contractual relationships, including any action / defense in court and, therefore, indicatively for the eleven years following the conclusion of the relationship itself, in accordance with the time limits set by law for the conservation of documents for tax, administrative and legal purposes, and with the discipline of the extinguishing prescription of rights pursuant to art. 2946 of the Italian Civil Code ...

#### RIGHTS OF THE INTERESTED PARTY

Pursuant to European Regulation 2016/679 (GDPR) as well as national legislation, the interested party may, according to the methods and within the limits established by the aforementioned legislation, exercise the following rights, by referring to the contacts indicated at the bottom:

Request confirmation of the existence of an ongoing processing of their personal data, having the right to a copy of the same;

Request the updating, rectification, integration and cancellation of their personal data, such as those no longer necessary for the pursuit of the purposes for which they were collected or otherwise processed; Request the limitation of the processing of their personal data;

Object, for reasons connected with one's particular situation, to the processing of one's personal data based on a public interest or on a legitimate interest of the owner and the right to object at any time to the processing of data for direct marketing purposes;

Unconditional withdrawal of consent, when the treatment is based on consent, with the warning that, in the event of revocation, the treatment remains lawful until the date of revocation;

Portability of their personal data;

Issue a complaint to the supervising authority.
